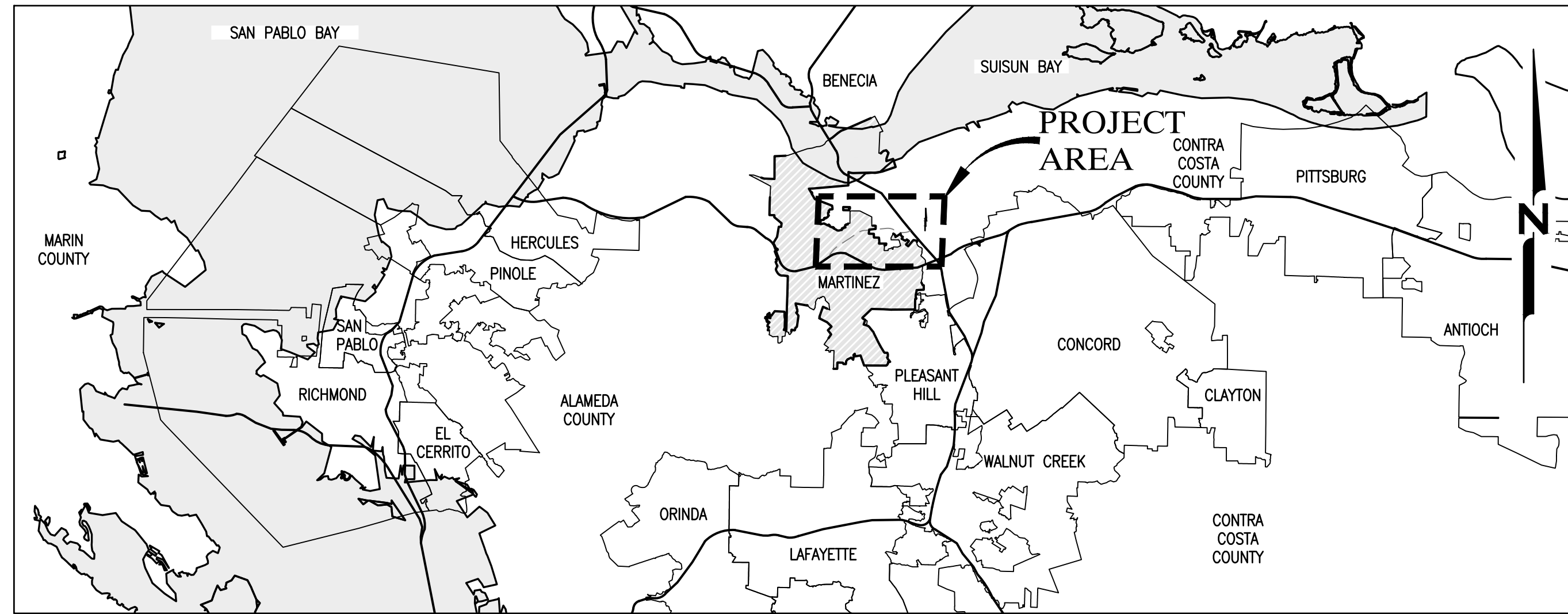

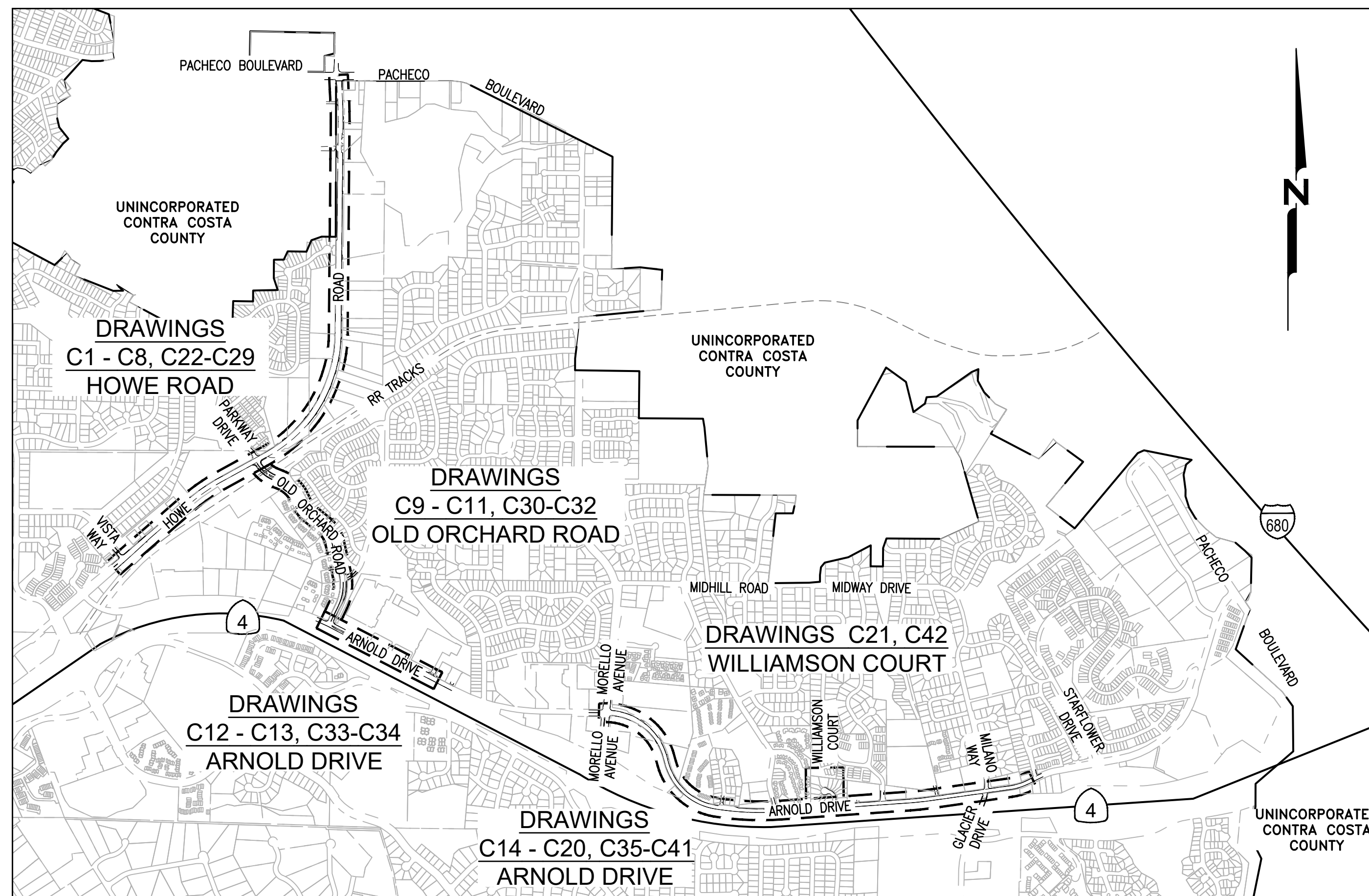

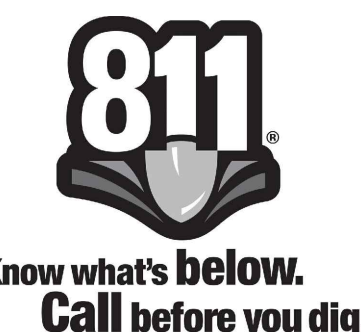
LOCATION MAP

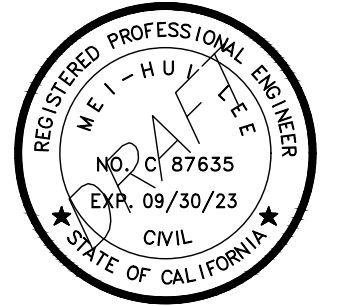
VICINITY MAP
