BYLAWS SECTION 9.3 BEHAIVOR POLICY (PLEASE INITIAL)

The parking lot is permit parking only. (Municipal Code 10.80.010 - Private Off-Street Parking Facilities). All cars parked in the lot are required to have a current years parking pass.
