**Subject:** Climate Action Plan and Sustainability Programs Update

### **Recommendation**

Receive report, hold discussion and provide input to staff regarding the City's Climate Action Plan and Sustainability Programs.

This report is provided for informational purposes. Staff will provide a brief presentation to accompany this report that will also include information on FY 2019-20 programs.

### **Background**

The City continued to make significant progress over the past year in support of its Climate Action Plan and Sustainability programs. The following list reflects recent key accomplishments or notable metrics.

- 1) Completed 4<sup>th</sup> Year of Martinez Unified School District Recycling Project
  - a. Program partners New Leaf Collaborative, Martinez Unified School District (MUSD), and Republic Services
  - b. Transition agreement for 5<sup>th</sup> year executed on July 2, 2019
    - i. Primary emphasis on MUSD K-5 students
    - ii. Core components: educational reinforcement in classrooms and cafeterias, "Green Team" engagement, teacher champions/liasons, and custodial support
  - c. Positive reinforcement through special "EarthCapades EcoCelebration" events at all MUSD K-5 campuses
  - d. Special recycling presentation to Kiwanis on March 21, 2019
- 2) Conducted 4<sup>th</sup> Year of Martinez "EcoAwards"

Local schools and businesses recognized January 16, 2019; recipients included John Muir Elementary, Las Juntas Elementary, and the Martinez VA Outpatient Clinic
- 3) Secured Staff Resources

Hired 7<sup>th</sup> part-time Sustainability Programs Assistant since 2012



- 4) Secured Technical Assistance for City Hall Energy Efficiency Upgrades  
Continued utilization of no-cost technical assistance secured through the East Bay Energy Watch (EBEW). Recently initiated review of third-party energy services company to provide updated analysis, cost and financing options.
- 5) Initiated Transition to MCE Clean Energy Deep Green  
Move approved through Council on October 23, 2019; will result in 100% renewable-sourced energy for all Martinez City Hall Electricity Accounts
- 6) Provided Compost Giveaways 2x/year to Residents through Republic Services  
Approximately 352 residents participated this year (compared to 205 last year) and 732 have taken advantage of this program since its inception in August 2016. Events were held in conjunction with the March/August Marina Swap Meets and included Styrofoam collection.
- 7) Coordinated Special Reuse and Recycling Events through Republic Services  
"Reuse Roundup" event (7<sup>th</sup> annual) held October 19<sup>th</sup> at Alhambra High; special post-holiday plastic and Styrofoam pickups provided January 2019 for second consecutive year at two locations.
- 8) Hosted Earth Day Booth and Compost Workshop  
April 2019 Earth Day celebration event marked 11<sup>th</sup> consecutive year City has hosted a booth with information on its sustainability programs. City also hosted a Recycle Right/Home Composting Workshop for residents.
- 9) Continued Sustainable Contra Costa Partnership  
Contributed "Sustainer" level partnership to build on longstanding partnership. Helped promote the 2019 Cleaner Contra Costa Challenge ([www.cleanercontracosta.org](http://www.cleanercontracosta.org)).
- 10) Commenced Participation in "Last Plastic Straw" Initiative  
Hosted special presentations of local grassroots initiative ("Contra Costa County's Last Plastic Straw") in January 2019 with AB939 Managers' Group and City Council; recently coordinated liaison with Chamber of Commerce and Main Street Martinez to engage business community.
