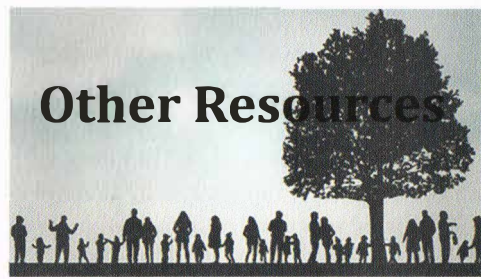

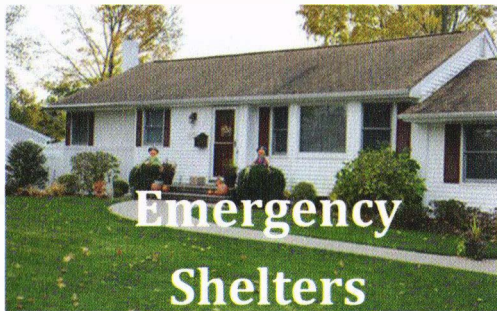

1) Despite official restraint of the person  
arrested in this matter, they may be  
released at any time - for updated  
information on their release contact  
VINELink at [www.vinelink.com](http://www.vinelink.com)

2) For more information about California  
Victims' Compensation Program, you may  
contact 1-800-777-9229.

3) You may ask the District Attorney to  
file a complaint in this matter.

4) You have the right to go to the superior  
court and file a petition requesting any of  
the following orders for relief:

An order restraining the attacker from  
abusing you, family members, molesting  
or interfering with minor children in your  
custody;

An order directing the attacker to leave  
the household; An order preventing the  
attacker from entering your residence,  
school, business, or place of employment

An order awarding you or other parent  
custody of or visitation with a minor  
child/children;

An order directing the party not granted  
custody to pay child support if legally  
required to do so;

An order directing the defendant to make  
specified debit payments coming due  
while the order is in effect; and

An order directing either or both parties  
to participate in counseling.

5) You have the right to file a civil lawsuit  
for losses suffered as a result of the abuse  
(medical expenses, loss of earnings, other  
expenses for injuries or damage done to  
property, other related expenses incurred  
by you or any agency that shelters you).

6) After a sexual assault, contact the  
Community Violence Solutions 24-hour

7) Sexual assault and domestic violence  
that is perpetuated by someone you  
know, including a spouse or a partner, is a  
crime.
