# Background

- Certain economic trends are converging, providing Martinez the opportunity to improve and expand its industrial sector:
  - Reshoring of supply chains
  - Success of e-commerce and technology businesses in the Bay Area
  - Exhaustion of industrial-zoned land in Santa Clara, San Francisco, and Alameda Counties



# Background

- Zoning Ordinance is outdated and provides unnecessary obstacles to new high-value industrial development
- Current regulations incentivize low-value uses like vehicle storage and junkyards
- Worked with economic development consultants and researched best practices from other jurisdictions like Berkeley, South San Francisco, and San Leandro that have successfully attracted high-value industrial uses to develop recommendations for the City's industrial zoning regulations



#### **Potential Revisions: Uses**

- Existing: the "Permitted Uses" section of the Zoning Ordinance lists specific and outdated uses.
- Recommendation: consider moving to a category-based approach that permits a broader range of uses and provides flexibility for future uses.



# Potential Revisions: Height

- **Existing:** allow maximum of 30 feet in height in the HI and LI districts, and 36 feet in the RD district.
- Recommendation: consider a maximum height of 48 feet by-right in the HI, LI, and RD districts.



### Potential Revisions: Setbacks

- Existing: require a 20-foot front yard and 100-foot back yard in the HI and LI districts. A 30-foot front yard and 20-foot rear and side yards are required in the RD district.
- **Recommendation:** consider reducing these setbacks to 10 feet (front) and zero feet (rear and side), except where abutting a residential district.



#### Potential Revisions: Floor Area Ratio

- Existing: The General Plan imposes a floor area ratio requirement of 0.4 on industrial zones.
- **Recommendation:** consider removing this requirement from the General Plan and moving to the Zoning Ordinance, along with increasing the base limit and creating an exception process, or eliminating it entirely and reverting to a lot coverage requirement.



# Potential Revisions: Landscaping

- **Existing:** require the front yard to be landscaped in the HI and LI districts, and landscape plans are required to be reviewed by the Planning Commission in the RD district.
- **Recommendation:** consider reducing this requirement to 50%, and removing the requirement that landscaping in RD be reviewed by the Planning Commission.



# Potential Revisions: Parking

- Existing: require one parking space per 600 square feet of floor area.
- **Recommendation:** consider reducing this requirement to one parking space per 1,000 square feet of floor area.



# **Next Steps**

- Staff is working on a comprehensive update to Permitted Uses and Conditional Uses, and any revisions recommended by the City Council will be included in that effort, except for any potential changes to the General Plan.
- Planning Commission: April 9<sup>th</sup> (tentative)
- City Council: May 1<sup>st</sup> and 15<sup>th</sup> (tentative)

# HIGH FIRE HAZARD SEVERITY ZONES

- What is a Very High Fire Hazard Severity Zone Map?
- California law requires local jurisdictions to identify areas with a very high fire hazard potential. Modeling is utilized to help assess the likelihood of a fire occurring in an area due to local conditions, such as fuel (material that can burn), and some areas are then designated as a Very High Fire Hazard Severity Zone on the Cal Fire maps.

So what are our FIRST STEPS towards WILDLAND FIRE preparedness in our community?






# Mitigation Strategies


- Increase public awareness; about evacuation protocols, emergency notification systems.
- Enhance use and knowledge of public emergency notification systems.
- Improve preparedness, evacuation planning, Emergency Go-Bags, family planning, predesignated safe zones.
- Infrastructure improvements; improve roadways, signage, vegetation management, reduce fire hazards along evacuation routes.
- 5. Traffic management; develop traffic management plans that include contraflow measures, rerouting of traffic,.
- Vulnerable populations; persons with physical movement restrictions, tourists and individuals without vehicle access.





#### **Exercise Objectives**

- Design and execute a limited evacuation of residents from a high severity fire zone within the incorporated area of the City of Martinez.
- Exercise the use of public emergency notification systems used by the City of Martinez and the Contra Costa County Warning System (CWS).
- Exercise both law enforcement and fire policies and procedures related to safe evacuation of residents residing in the targeted area of the exercise. This will include identifying potential evacuation routes, safe zones, and local evacuation center(s).

#### **Exercise Objectives continued**

- Key government agencies
  - Contra Costa County Fire Protection District, Sheriff's Office, CHP, Community Emergency Response Teams (CERT), Animal Control
- Non-government organizations who may be requested to support evacuation operations
  - American Red Cross, PG&E, local transportation agencies.
- Enhance community awareness of wildfire threats and provide public education on evacuation preparedness presented by our own Martinez's Community Emergency Response Team (CERT) members.

## **Simplification of Fee Structure**



- Less categories; more standardization
- Added non-profit and business rate
- Added summer camp fees
- Special event section untouched
- Add 3% credit card transaction fee
- Annual adjustments recommended based on CPI



### **Proposed Adjustments**



- Covers facility rentals, picnic rentals, sports fields, summer camp, aquatics,
- All adjustments are mid-range of market
- Generally, adjustments are between \$20 - \$50 range
- Largest proposed adjustment is tournament fees
- Smallest proposed adjustment are in facility rentals

# Planning Fee Schedule Updates



- Minor Amendments based on hourly rate
  - Consultant Services and Peer Review
  - Fee Deferral Application
  - Housing Projects Eligible for Streamlined and Ministerial Review
  - Temporary Use Permits
- Tree Removal Mitigation (in-lieu) Payment cost of the tree, soil amendments, irrigation, and labor
- Program to reimburse Applicants up to \$5,000 or 50 percent of the cost for Consultant Services and Peer Review fees, whichever is less, upon issuance of a building permit
- Effective July 1, 2024

#### Recommendation



Adopt a resolution amending the City's User Fee Schedule for City Services and determining the project is statutorily exempt pursuant to Public Resources Code Section 21080(b)(8) and CEQA Guidelines Section 15273(a) since the fees being established are for the purposes of meeting operating expenses.




#### **Top Five Collisions by Primary Collision Factors**






#### **Collision Analysis – Top 12 Corridors**





#### **Calm Aggressive Drivers**

High-visibility enforcement through highly visible patrols, such as checkpoints, saturation patrols, or message boards.

Coordinating traffic signals at a lower speed has shown to be effective. Speeds during nighttime are usually higher so signals could be coordinated at a lower speed.

  - Rates not adjusted at that time








#### **Ad Hoc Subcommittee**

 Mayor Zorn and Councilmember Ross were appointed to a Solid Waste Ad Hoc Subcommittee on March 15, 2023, via Resolution No 030-23





## Exclusive Negotiation Process

 First tried in July 2021, but tabled due to hauler staffing issues, absenteeism and poor customer satisfaction survey results





#### **Exclusive Negotiation Process**

- Second instance, per Council direction in 2022, with negotiations in earnest in summer 2023
  - However, another round of service problems and hauler expressed financial needs scuttled the City's pursuit of long-term agreement

## **Negotiations Process**

- Current term for the Agreements ends January 5, 2025
- Initial negotiations pursued restatement and 10-year extension
- City pivoted to 3-year extension via amendment, to January 1, 2028
  - Key extension advantages retained
  - Base Year Rate Adjustment process triggered early due to Republic revenue shortfall



## **Key Terms**

- > Extensions to January 1, 2028
  - > Allows for correction of operational issues
  - Provides time for RFP (if necessary)
  - > Provides time to monitor neighboring communities
- Credit for Missed Collections
- Liquidated Damages for Delayed Routes
- > Trigger early Base Year Review
  - New Base Year rates to be in effect September 1

  - CPI-based rate adjustment for January 1, 2025 (CPI + 3.1%)

Mayor and City Councilmembers,

We will not be able to attend the Industrial Zoning Special Meeting and Study Session and would like to offer the following thoughts.

- 1. It is good to see the City directing this effort to help the commercial and industrial sector of Martinez grow. We believe that growth of this sector is one of the best ways to increase our tax income and has other significant benefits to Martinez. We have been encouraging thinking along these lines for a long time.
- 2. It is our understanding that, unlike most of the recent zoning changes, this is NOT primarily motivated by State demands that are required to get our Housing Element approved.
- 3. Two comments: we believe the 48 ft. height allowance is too high to be the starting point. The same applies to the zero side and back setbacks. Both will be out of scale for our town and for most existing industrial/commercial areas. Not allowing these massive structures is especially important (a) in some existing industrial/commercial areas, (b) in those areas that are exposed to or in close proximity to residential neighborhoods and supporting commercial/retail areas and (c) in those areas that act as scenic ways into and out of our town--for instance Arnold Drive and the southern portion of Howe Rd. They could be allowed as discretionary limits subject to City approval.

Thank you for considering this input. We would appreciate your adding this to the meeting record.

#### Mayor and Councilmembers:

I see that the City Council will be discussing possible changes (increasing height and density) to the City's Industrial zoning at the Council's Special Meeting on March 20, 2024. I suppose the proposed zoning makes sense for industrial uses, but feel that there needs to be an analysis of what might happen if a *residential* developer comes in with a proposal that takes advantage of State laws allowing high density residential, potentially with a density bonus, on commercial and industrial sites. Under these State mandated rules, zoning densities and height limits essentially become the base upon which additional height and density can be added.

Take, for example, the light industrial lots along Berrellessa on the north side of the railroad tracks. What would a potential residential project look like now with the curent 30 feet plus density bonus height, versus 48 foot plus density bonus height under the proposed changes? Is a residential tower really what we want to see on the marina side of the railroad tracks? The industrial lots along Howe Avenue backing up against the Morello Heights neighborhood should also get a look. What might neighbors see over their back fences?

Consideration of Potential Industrial Zoning Regulations Revisions

I agree with D. Gordon's description of the rationale to revise the Industrial Zoning.

However, the solutions to create new appropriate zoning standards for developing high rise building heights, skimpy side, fronts and back setbacks along with no landscaping strike me as isolated from the regional climate conversation goal of a climate resilient future for all of us.

Many questions arise for climate change mitigation in industrial zones. To cite a few:

- 1) as neighboring (residences, commercial offices, etc,) have solar panels—will tall industrial buildings be sited with wider setbacks from shadowing nearby sunlight electrifying solar panels?
- 2) Barren land with no landscaping? The revised zoning regulations could require landscaping of healthy trees and ground covers, storm water drainage swales,etc to absorb fossil fuel emissions-sequester carbon. Lack of an urban forest that sequesters carbon.
- 3) The Regulations are an opportunity to 'grow' local Industrial Parks that may receive funding from the complex Inflation Reduction Act.

My name is Zoe Carpenter and I live at 1025 Brown Street. My home is located one block west of the intersection of Pine Street and Brown Street.

I would like to first say thank you for inviting our community to speak tonight on the agenda items at this evening city council meeting.

I am here tonight to address the Local Road and Safety plan that is set forth in the staff report provided.

I have read through the Staff Report and the Local Roadway Safety Plan that is in progress for the city of Martinez. As well, I have reviewed some of the Federal and State project funding requirements in effort for grant funds to be provided to our city. One major aspect of funding is our Local Roadway Safety Plan-LRSP and the givernmental requirements to be provided the LRSP to ask for funding including grant money from other State and National organizations. I'm thrilled to know that this process is being investigated. As well we all know these processes are lengthy and time consuming. The stakeholders list appears extensive and I am thankful for that.

Other very important stakeholders are those of us here in the room, those on the phone and those unable to be here to present and speak for themselves. We are those immediate stakeholders that are witnessing and suffering in many forms the severe traffic issues we have now in our community that impact our daily lives and the need for these issues to be addressed immediately so that we are not another "Reduced Fatality or seriously injured person". Reduction of fatalities and reduction of seriously injured persons are ever present terms that are used in our own local roadway safety plans, California's Safe Roads

Strategic highway plans, and US highway safety plans. Reductions of fatalities and seriously injured leaves me to think about a missing term.

That term is PREVENTION. One term that I think needs to be used ubiquitously is PREVENTION of fatalities and injured persons. We need to prevent these problems and this city needs immediate implementation of projects and processes to start this preventative measures.

Like I said before I live one house over from the corner of Brown Street and Pine. Every single day I see drivers running the stop signs at that intersection, speeding through without so much as even a California Stop, turning onto the perpendicular streets, speeding through the stop signs without care to oncoming traffic, pedestrians and bicyclists. Myself and my two dogs have almost been run over three times while crossing the Brown Pine street intersection. Once in the late evening by a local Sherriff SUV that did not adequately stop and did not see us in the dark intersection.

One could sit at that corner for just one hour and witness egregious traffic violations one after another.

In the past four years these are the traffic incidents that I have been a personal recipient of - along with the approximate costs to my person

- 1. HIT and RUN My daughters Honda was broadsided while parked on Brown Street in front of my house required body shop repairs. My deductible \$500.
- 2. HIT and RUN My own personal truck was broadsided while parked on Brown Street in front of my house, which required body shop repairs. My deductible \$500

- 3. HIT AND RUN: My housemates Subaru was broadsided while parked on Brown Street in front of our house required body shop repairs. Her deductible \$500
- 4. HIT AND RUN: A friends Mercedez was broadsided while parked on Brown Street in front of my house required body shop repairs. Her deductible cost \$1000
- 5. HIT AND RUN: My house sitters JEEP was recently rear-ended which subsequently slammed into my car, both vehicles Parked on Brown Street in front on my house. BOTH cars were completely totaled and had to be salvaged and replaced. It is known to be a silver Toyota Camry but never a driver detained Insurance did not cover her car as she had liability only. This cost her over 12 thousand dollars to purchase a new used vehicle. My car was also totaled and insurance did not pay the replacement cost for my new used same year car. This cost me \$5000. It may seem obvious but I need to mention that if a driver has totaled two vehicles, one houselength from the intersection, they not only ran that stop sign but had to have been traveling at excessive speed. We are lucky no one was killed.
- 6. I personally witnessed a driver speed through out intersection come up onto my yard and break off two almost full grown crepe myrtle trees at their base and push them into my neighbor's yard. I urged him to get out of his car, rather he pulled back quickly towards me and sped off. I was lucky he did not run me over. Had I been tending to the yard area around the trees and been hit by this driver, I certainly would have been a fatality. I am frequently in my yard tending to my yard and garden. I frequently feel unsafe and us pilons to draw attention. The replacement of those two trees cost me well over \$10,000 dollars. This may seem like an amount hard to believe but large

trees are VERY expensive to replace. Not only the high cost of the trees, but landscapers to place them, tractors to dig large holes and cranes to drop the trees in. I am thankful it was trees and not my own life that was lost.

This total out of pocket for these 6 items I have mentioned is approximately 30 thousand dollars. That is not to mention the costs that insurance companies had to pay after deductibles. THIS IS COMPLETELY UNACCEPTABLE AND PREVENTABLE. There needs to be swift and immediate action take at this intersection.

There are several resolutions outlined in our Local Roadway that should have and could be used to reduce these issues at Brown and Pine as well as many other intersections through-out our city. I will go through a few from the report to point them out, For example

In section

### B.2 Intersection Countermeasures - Non-signalized intersections

NS08, Install Flashing Beacons at Stop-Controlled Intersections

NS10, Install transverse rumble strips on approaches

NS22PB, Install Rectangular Rapid Flashing Beacon (RRFB)

NS23PB, Install Pedestrian Signal (including Pedestrian Hybrid Beacon (HAWK))

**B.3 Roadway Countermeasures** 

RO1, Add Segment Lighting

R34PB, Install sidewalk/pathway (to avoid walking along roadway)
There are many places in the city, specifically southbound on Pine
Street where no sufficient sidewalk exists and we are forced to walk
in the street with the traffic

R36PB, Install raised pedestrian crossing to help lower speed approaches and safety of walkers

R37PB, Install Rectangular Rapid Flashing Beacon (RRFB) THIS COULD BE OF GREAT SAFETY AND TRAFFIC SLOWING IMPACT IN MY BELIEF.

Another item that is not mentioned is speed calming bumps. Why not them?

These are only a few of the possible resolutions written in your report, but in the meantime perhaps a sitting police officer might curb the issues a bit

Though I PERSONALLY have not YET been a "fatality or seriously injured person" at that intersection, I am one of the recipients of these seriously wreck less said traffic violators.

You will notice as you drive down Brown Street that MANY households utilized traffic pilons to deter these hit and runs, but so far the hit and runs continue. I know of several other accidents on Brown Street and the intersection caused by speeding drivers, and drivers that do not stop at this intersection They continue to collide and hit and run. The cost the residents of this city undertake is not acceptable and we feel unsettled, unsafe, and inadequately protected from the drivers in this city. I am asking you with great kindness, and care for my neighbors that these issues be addressed immediately.

I thank you city council members and urge you to take swift and immediate action.
