## How to Submit a Building Permit Application During the COVID-19 Shelter in Place Order

Only emergency and essential permits will be issued during the COVID-19 shelter in place. All others will be processed and, if approved, will be issued when the shelter in place order is lifted.

- Complete the building permit application, which can be found here: <a href="https://www.cityofmartinez.org/depts/building/forms.asp">https://www.cityofmartinez.org/depts/building/forms.asp</a>
  Type or write clearly and include an email address so we can reach you if needed.
- 2. Save application as a pdf file to your computer desktop using a distinct file name with the street address of the project. For example: Building Permit -1234 Easy Street. Email permit application to Building Department Permit Technician, Lisa Luna at <a href="Luna@CityofMartinez.org">LLuna@CityofMartinez.org</a> and she will calculate the fees. Note that we will accept payment by check only during this time.
- 3. Upload the application and fully dimensioned plans to our Hightail site: <a href="https://spaces.hightail.com/uplink/MartinezPermits">https://spaces.hightail.com/uplink/MartinezPermits</a>, and mail the check with a copy of the permit application, payable to the City of Martinez to:

- 4. Alternatively, mail the permit application, check, and three (3) fully dimensioned plans to the same address.
- 5. City Staff will begin review of the application once payment has been received. You will receive a written receipt of your payment when the City receives it.
- 6. City Staff will respond via e-mail with comments on the plans, if any.
- 7. City Staff will inform you when your permit is ready, however <u>only permits for</u> <u>essential projects will be issued during the quarantine.</u> All other approved permits will be issued after the quarantine is lifted.

The City will require three (3) hard copies of final plans prior to permit issuance.

A list of the essential projects allowed by Contra Costa County Health Service order during this shelter in place is below.

## Essential Projects Allowed Under Contra Costa County Health Services Shelter in Place Order of 3/31/2020

- 1. Projects immediately necessary to the maintenance, operation or repair of Essential Infrastructure;
- 2. Projects associated with Healthcare Operations, including creating or expanding Healthcare Operations, provided that such construction is directly related to the COVID-19 response;
- 3. Affordable housing that is or will be income-restricted, including multi-unit or mixed-use developments containing at least 10% income-restricted units;
- 4. Public works projects if specifically designated as an Essential Governmental Function by the lead governmental agency;
- 5. Shelters and temporary housing, but not including hotels or motels;
- 6. Projects immediately necessary to provide critical non-commercial services to individuals experiencing homelessness, elderly persons, persons who are economically disadvantaged, and persons with special needs;
- 7. Construction necessary to ensure that existing construction sites that must be shut down under this Order are left in a safe and secure manner, but only to the extent necessary to do so; and
- 8. Construction or repair necessary to ensure that residences and buildings containing Essential Businesses are safe, sanitary, or habitable to the extent such construction or repair cannot reasonably be delayed.
